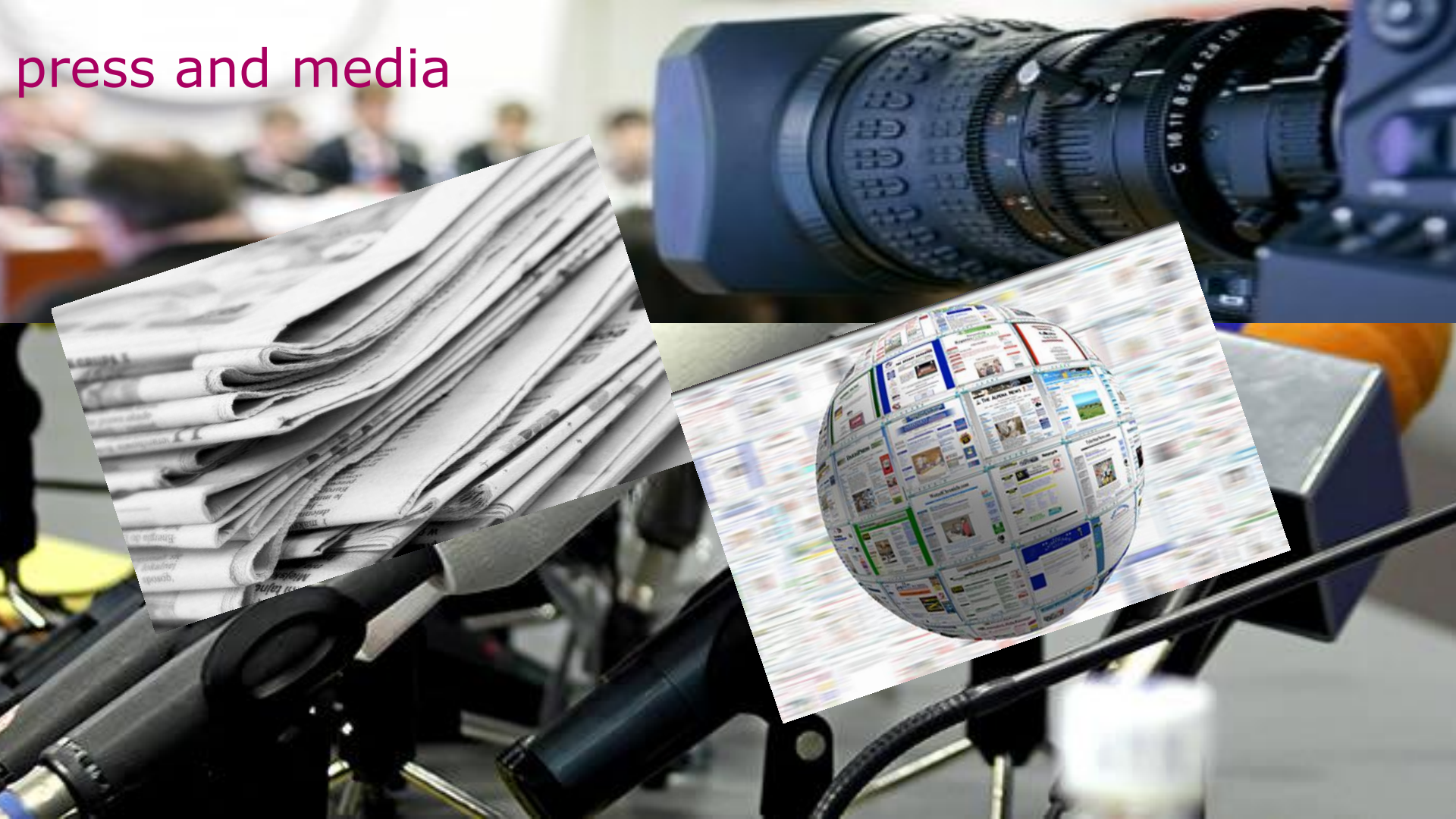

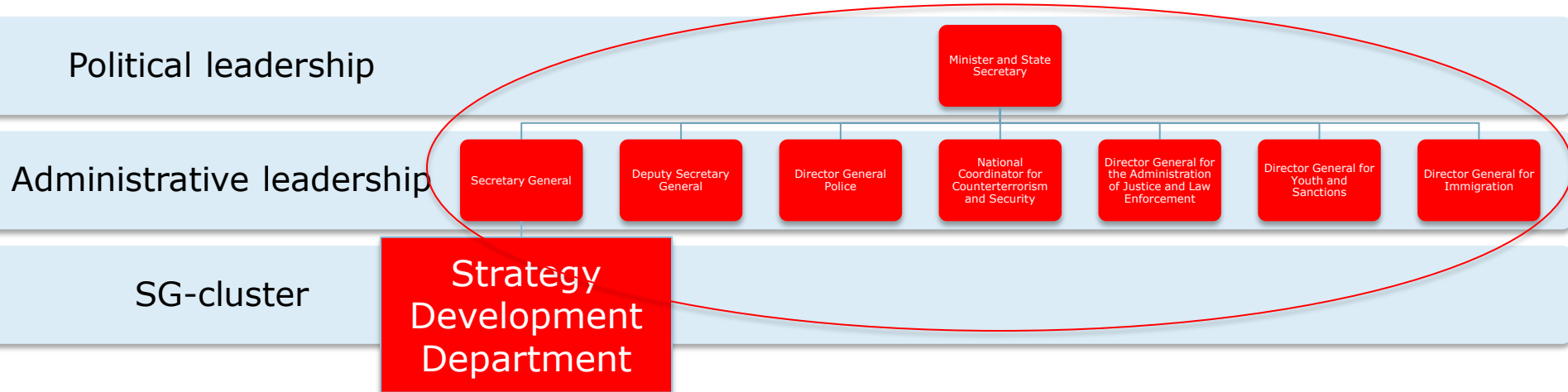

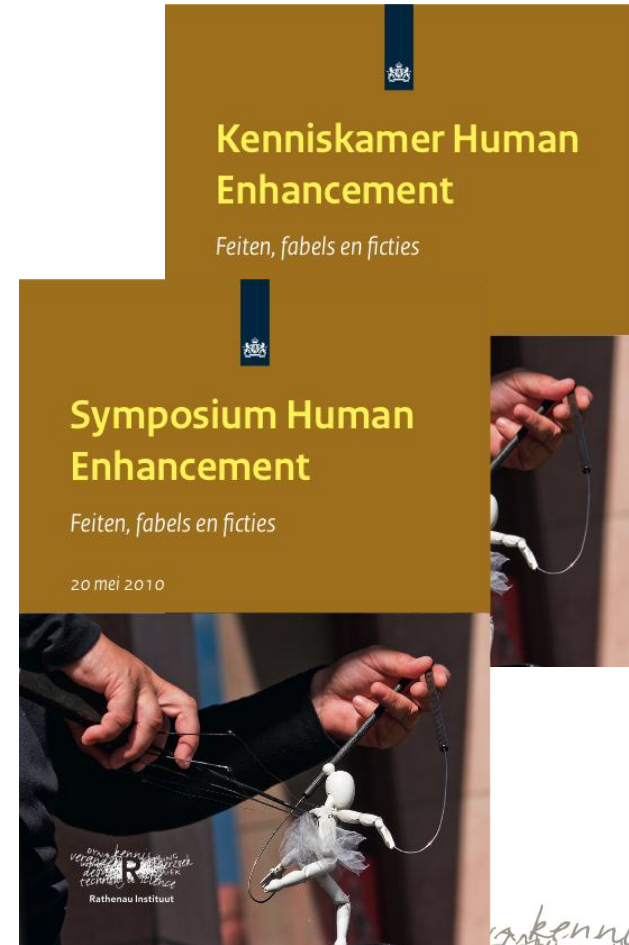
Why co-operation
